ELIGIBILITY/COMPATABILITY REQUIREMENTS:

1. Applications for this position will be accepted from current SCANG members in the GRADES of E-1 to E-6.
2. Applicants MUST be 3P0X1 AFSC qualified to be eligible for consideration for this announcement.
3. This position is "FENCED". The selected "APPLICANT" is ineligible to apply for other "ON BOARD" AGR announcements outside of 169th SFS unless stipulated that "FENCED" SFS personnel may apply.
4. E6 applicant if selected MUST take an administrative reduction to the grade of SSgt/E-5.
5. This is a one-time tour of 3 years. To be considered for an additional tour after initial tour, you must reapply for advertised position.

ADDITIONAL QUALIFICATION REQUIREMENTS (ANGI 36-101 DATED 3 JUNE 2010):

1. Applicants must meet all accession requirements IAW AFI 36-101, Chapter 5, Active Guard Reserve Program.
2. Applicants must be able to attain/possess the required SECURITY CLEARANCE
3. Applicants must have a current AF Force Fitness Test Score of 75 or higher within the last 12 months to be eligible for consideration.
4. Applicants previously separated for cause from Active Duty are ineligible for entry into the AGR Program.
5. Applicants may apply if unable to attain 20 yrs active federal service prior to Mandatory Separation Date (TAG Waiver required).
6. Selected applicant MUST meet Medical Fitness Standards IAW AFI 48-123 for entry into the AGR Program.
